## MEMBER SPOTLIGHT

Glenn has 4 NM State Championships to date. Glenn has also won 1<sup>st</sup> Place for the past five years in IDPA in the AZ State Championship and in 2009 he won the coveted IDPA National Championship in the CDP (Custom Defense Pistol) Division. He won 2<sup>nd</sup> Place in the IDPA Winter Nationals twice and 2<sup>nd</sup> Place in 2009 in the Multi-Gun Nationals. Glenn also shoots USPSA (United States

Practical Shooting Association) and in 2009 won the Master Class - Limited, as well as winning Master Class - Limited in the Sectional Championships from 2007 to 2009. He placed 7<sup>th</sup> in the over-all standings in the USPSA Single Stack Nationals. This talented young shooter has been sponsored by Wilson Combat since 2007, which provides him with guns, match fees and travel expenses. Glenn thanks and appreciates Wilson for their support, without which it would be difficult to compete in the various competitions he attends nationwide. In addition to Glenn's passion for shooting in IDPA and USPSA, he has worked for Adobe Contractors for the last 10 years or more. **SJWF** is indeed proud to have such a talented shooter and club member in their ranks!—CM
