ANOTHER BYLAWS CHANGE PROPOSED

Following the discussion on the proposed change in the club's bylaws during January's general meeting, concerns brought to light that night, were discussed further at the board meeting on February 7th. As a result, an additional bylaws change is proposed by the Board of Directors, that addresses those concerns and reflects our club's common goal. That is to reach out to the coming generation, by encouraging them not only to experience the organized activities provided by the San Juan Wildlife Federation, but to also experience the responsible mentoring and education provided by individual members.

Therefore, the Board of Directors of the San Juan Wildlife Federation hereby proposes the following Addition to Article III Section 2 of the Bylaws:

Addition to Article III section 2

6. Nonmember children and youth, under the age of 18, while supervised and mentored by a member, can use the SJWF range with no fee. Each child is required to have a hold harmless agreement signed by their parent or legal guardian prior to using the facility.

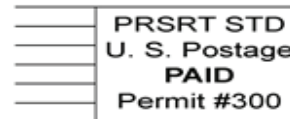
