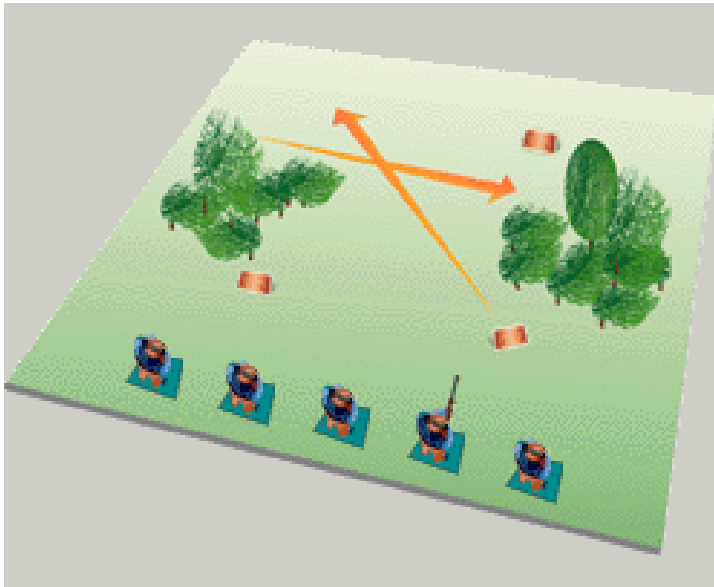


HAPPY NEW YEAR!

CONCEAL CARRY CLASSES

Conceal carry classes for a State of New Mexico Conceal Carry License, are offered in association with the San Juan Wildlife Association.
