

NRA STYLE JUNIOR SPORTER AIR RIFLE LEAGUE

San Juan Wildlife Federation (SJWF) is currently organizing a Junior Air Rifle league. The Sporter Air Rifle League will be conducted indoors and will held year-round..

The Sporter Air Rifle League will consist of three divisions, Junior, Intermediate and Sub-junior. The Junior Division consists of eligible participants from 18 to 20 years old. The Intermediate division of 15 and 17 year olds. The Sub-junior of 8-14 year olds. Participants under the age of 15 must be accompanied by an adult.

Participants may use air rifles provided by the San Juan Wildlife Federation or may choose to use their own air rifle as long as it complies with the specifications in the Sporter Air Rifle Position Rule Book. Pellets and targets are provided by the SJWF. **Fee is \$5.00 per shooter per match.**

The matches will be held **Saturday** evenings unless otherwise noted in the SJWF Match Schedule. Each match will consist of 10 rounds in each of the standing, kneeling, sitting and prone positions. Fifteen minutes will be allowed for the prone position and 20 minutes for each of the other positions. Five minutes will be allowed for scoring of each position's targets and 5 minutes will be allowed for each change of position.

The first organizational meeting will be held at 6:45 P.M., March 18, 2012 at the SJWF club house. The entrance to SJWF is off the Bloomfield Hwy just west of the Sinclair station on the north side

of the highway. Any changes to the match rules, day and times will be discussed at this meeting. Sign-up sheets will also be available during the meeting.

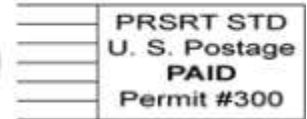
