LETTER TO MEMBERS

At the last Executive Committee Meeting held March 4th, the proposed 2013 budget for SJWF was presented. This year's numbers are based upon the income and expenses for 2012 and included monies set aside for fixed expenses like utilities, taxes, insurance and etc as well as maintenance and capital expense projects. The net result of 2012 was an income to the Range less than \$14,000. Based on that net income, the Committee is forced to find ways to cut expenses and improve the bottom line of the Club.

A major expense is the printed Newsletter. We are currently spending nearly \$9,000 per year, to print and mail out paper copies of the monthly newsletter, which is already published and available to members a week earlier on the sjwf.org website.

We understand the value of our newsletter. Besides keeping members informed of news and events, it is also used as a reminder of membership renewal dates. These days very few of us don't have the internet available to us at work or at home. On our website, www.sjwf.org, a simple click on the newsletter menu tab, delivers the current newsletter as well as all back issues.

Therefore, it is the decision of the board, that the May 2013 newsletter shall be the last one mailed to members. Beginning with the June issue, members, who want a paper copy, can download and print it in color with a simple mouse click on your home or office computer.

As for renewal reminders, we will send reminders to members via e-mail, to all those who have given us addresses. If you have not already done so, or want to make sure that we have your e-mail address, send an email to security@sjwf.org and in the subject line put "address update". You will be added to the data base and a renewal reminder will be sent to you 30 days prior to your membership expiration.

It has been our experience, that even with the renewal date printed on the paper newsletter, too many of our 800 members were allowing their memberships to expire and then calling a club officer and asking them to drop whatever they were doing, go to the range, accept their dues and reactivate their gate card. Such requests has become a serious time burden on certain officers and can't continue. Officers are always available at the Club on Board Meeting night and General Meeting night each month. Check the club calendar on the newsletter. If you cannot renew your dues by mail, your dues will be accepted at one of these two events. Officers will no longer make special trips to the range because someone neglected to pay their dues when they were due.

We do not wish to place hardship on anyone, but we do have to address changes that make us more fiscally responsible in these challenging economic times. Just as we experience in our personal lives, as a club, there are times we have to tighten our belts. — Bill Standley, President

Interested potential students may call Mike Freestone (325-5355) or Bond Kinney (330-2475) . Students can also sign up at East Main Trade. Fees: \$175.

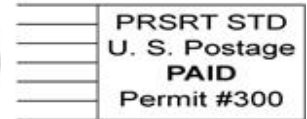
NRA COURSES
