



**2016 SHERIFF'S 3-GUN CHARITY CHALLENGE**

The 3<sup>rd</sup> Annual Sheriff's 3-Gun Charity Challenge match was held at the San Juan Wildlife Federation from April 29<sup>th</sup> to Mat 1<sup>st</sup>, 2016. A total of 59 competitors shot the nine stage Individual course of fire. Twenty of the shooters were match staff and 39 were paid competitors. Approximately 7,500 rifle, 8,500 handgun and 7,500 shotgun rounds were fired during the event. -Continued next page.
